ELIGIBILITY AND GUIDELINES

Please read all instructions carefully.

If you have any questions, contact the PSI Scholarship Chair (info on next page).

1. Eight (8) \$2,000 scholarships will be awarded to high school seniors through the Paper Stock Industries (PSI) Chapter and Institute of Scrap Recycling Industries (ISRI) Recycling Research Foundation.
2. Each scholarship is to aid a dependent of an individual who has been employed for at least one year by a CURRENT ACTIVE MEMBER COMPANY of the PSI Chapter. The employee must work in the RECYCLING DIVISION of the company. Dependents of officers, principles (owners, partners, etc.) are not eligible.
3. The applicant must have at least a C+ average in high school and meet all qualifications for admission to a regionally accredited two-year or four-year post-secondary institution.
4. The applicant must submit six (6) copies of each of the following, collated to create six (6) complete sets, each put together simply with paper clips, binder clips, or stapled (do not put in folders or binders):
 - completed PSI scholarship application
 - official transcript of all high school grades
 - SAT and/or ACT scores
 - two (2) letters of recommendation
 - résumé of the individual's personal history
 - an essay (one typed 8.5x11 page) on one of these topics:
 - A. *If you could have dinner with anyone in the world, living or dead, real or fantasy, who would it be and what would you talk about?*
 - B. *What book, work of art, scientific discovery, or invention has inspired you? How?*
5. The applicant may attend any regionally accredited two-year or four-year college of his or her choice; however, any charges over and above the amount of the scholarship will be the responsibility of the applicant.
6. Scholarship awards will be paid directly to the college of choice. In the event a recipient does not complete the full year or two (2) semesters, any refunds due MUST be paid to the PSI Chapter/ISRI Recycling Research Foundation.
7. The selection of the scholarship recipients shall be made by the PSI Chapter Scholarship Committee based on merit.
8. Scholarships will be awarded on an annual basis.
9. Application information will not be disclosed or sold to ensure the safety and privacy of the personal information of the applicant. The PSI Chapter has a records destruction policy for all submitted material.
10. Submissions will not be returned to the applicant. Please make a copy for your files.
11. **Applications MUST be complete and postmarked on or before March 31, 2019 to be considered.**

The PSI Scholarship Committee will notify the scholarship recipients in early summer.
